



## 9/11 Was An Inside Job!

### Provoked, fabricated, and “false flag” attacks are some of the oldest tricks in the

**book:** the Japanese bombed their own railway in Manchuria to “justify” an invasion of China;<sup>1</sup> German officers staged a “Polish” attack on a German radio station to “justify” their attack on Poland;<sup>2</sup> the US deliberately provoked the Japanese attack on Pearl Harbor and made sure it succeeded;<sup>3</sup> the US also sent commando teams into islands in the Tonkin Gulf to provoke attacks on the spy ships offshore (and then invented the “incident” anyway).<sup>4</sup> The US Joint Chiefs of Staff also planned attacks on Guantanamo Naval Station, terrorist attacks in the US, and the shooting down of a (remote-controlled) airplane — then to blame it all on the Cubans, then invade.<sup>5</sup> And the anthrax mailed shortly after 9/11 had been processed in a US Government lab.<sup>6</sup>

It is a well-established technique for goading countries to war. It is also useful for taking over governments (the Reichstag fire comes to mind).

**Powerful US hawks called for a “new Pearl Harbor:”** Zbigniew Brzezinski, President Carter’s National Security Advisor, founding member of the Trilateral Commission, and professor of international relations at Johns Hopkins University, reminded readers in 1997 that “democracy is inimical to imperial mobilization” and that the US only rose to the challenge of World War II after Pearl Harbor.<sup>7</sup> The Project For the New American Century, a neoconservative think tank which includes five members of the current administration, wrote in 2000 that only a new “Pearl Harbor” would enable them to get the military forces to carry out their “global responsibilities” for “leadership.”<sup>8</sup>

**US oil interests wanted a pipeline through Afghanistan:** John J. Maresca, Vice-President of Unocal Oil, told Congress in 1998 that the best way to get Caspian Basin oil to market is with a pipeline through Afghanistan, but that the Taliban were in the way.<sup>9</sup> RAND Corp. Fellow Zalmay Khalilzad (now a US Special Envoy

to Afghanistan<sup>10</sup>) also said that the Taliban were a problem.<sup>11</sup>

**The war had been planned for years:** the Clinton Administration drew up plans for a war on al-Qaeda (and Afghanistan) but left them for the incoming Bush administration to carry out.<sup>12</sup>

**Retired US diplomats told retired Pakistani diplomats in July 2001 that the US was considering the “military option” in Afghanistan:** they said the US could attack by mid-October<sup>13</sup> (the US started bombing on October 7).

**“Islamic” terrorists have been created and built up by the CIA with Saudi Arabia, Pakistan, and others, and the US continues to protect them:** Osama bin Laden was a top recruiter for the CIA’s mujahedin in Afghanistan, and the “fundamentalist Islam” of the terrorists is inspired by an ultraconservative sect allied with the Saud dynasty, a US client for decades.<sup>14</sup> US banks and oil companies continue close ties with the “virtuous” bin Ladens and other royal cronies,<sup>15</sup> and while officially Osama is a “renegade” banned from Saudi Arabia, he has continued to call his mother<sup>16</sup> and meet with his family.<sup>17</sup>



**Many countries, including close allies, say they warned the US of attacks:** Several repeated their warnings.<sup>18</sup> John Ashcroft quit flying on commercial airlines after a “threat assessment,”<sup>19</sup> and several top Pentagon brass canceled flights the day before 9/11.<sup>20</sup> Even San Francisco Mayor Willie Brown received a warning not to fly on 9/11.<sup>21</sup>

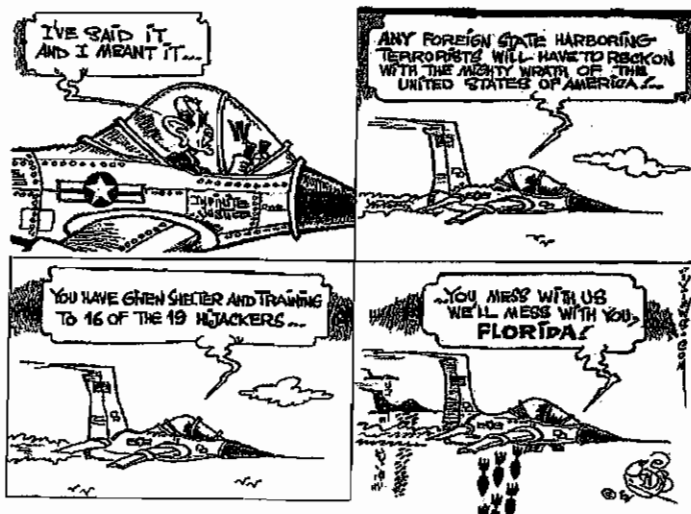


On September 11, 2001, the civilian and military air traffic control systems failed four times in one day to make intercepts which were standard procedure: FAA regulations require notifying the military as soon as a flight quits responding or is too late checking in en route. Fighter jets do not need special authorization to intercept commercial aircraft, only to shoot them down.<sup>22</sup>

Three of the accused terrorist pilots and five other "hijackers" trained at CIA-connected, drug-running flight schools.<sup>23</sup> Some "hijackers" trained at Pensacola Naval Air Station.<sup>24</sup> At least two lived with an FBI informant — but the FBI wasn't interested in them.<sup>25</sup>
