Dear Dr. Farrell:

When I was a UW-Madison student, Joe McCarthy was demagogically intimidating much of the academic community and US society by unjustifiably labeling political dissenters as unpatriotic subversives.

Today, some Wisconsin politicians are using similar techniques to intimidate and repress academic and societal consideration of controversial ideas about the 9/11 terrorist attacks - points of view which in much of the Muslim world are considered true, but which in the US are politically taboo.

### **UW-MADISON DEFENDS KEVIN BARRETT PROVOST PATRICK FARRELL HIDES BEHIND ACADEMIC FREEDOM**

State Representative Steve Nass (R-Whitewater) condemned the decision of UW-Madison Provost Patrick Farrell to defend the employment of Kevin Barrett as a lecturer. Mr. Barrett has been using his position at UW-Madison to advance his personal views that the 9/11 attacks were orchestrated by the U.S. Government and that al-Qaida is a CIA creation to divert public attention from the truth.

“Once again, the leadership of UW-Madison has displayed its ineptness and its disdain for the taxpayers. Provost Patrick Farrell is solely responsible for the continued embarrassment that Kevin Barrett will bring the university and the state,” Nass said.

Mr. Barrett is scheduled to teach an Introduction to Islam class at UW-Madison this fall. Mr. Barrett has a one semester, limited term contract with UW-Madison paying about \$8,500.

“If the overpaid administrators at UW-Madison feel justified in defending Kevin Barrett, then their decision will make it that much easier for me to fight for greater administrative cuts for the UW in the next budget. **They have academic freedom, but the taxpayers and the legislature have the power of the purse-string,**” Nass said.

Mr. Barrett confirmed that he does discuss his 9/11 conspiracy theories in the classroom. Mr. Barrett asserts that his employment at both UW-Madison and Edgewood College (Madison) proves that other academics don't find his claims as phony.

“The people of this state are middle-class families with traditional values, but this case demonstrates that the leadership of UW-Madison fears the wacky-left,” Nass said.

"Why would our government do this? To trigger a War that will not end in our lifetime." Says Kevin Barrett, a lecturer for UW-Madison who will teach a course on Islam this Fall.

Barrett is the founder of a group called the Muslim Jewish Christian Alliance for 9/11 truth, that has about 1,000 members worldwide. He says after three years of studying the evidence, he came to the conclusion 9/11 did not happen the way the government says it did. He believes the Bush Administration planned and executed the attacks on the World Trade Center.

"The physics of those collapses clearly could not have resulted from plane crashes and jet fuel fires with office materials." Barrett says jet fuel does not burn hot enough to melt steel, and says recent tests on melted steel from the building prove his theory that it was wired to collapse, by the Government.

Barrett says the Bush Administration is fooling the American public with the Adolf Hitler 'Big Lie Technique'... "Tell them a little lie and they'll wonder about it - weapons of mass destruction in Iraq was a relatively little lie - and people are getting called on it." Barrett says. Last Saturday, former Bush administration official Morgan Reynolds drew an enthusiastic capacity crowd to the Wisconsin Historical Society auditorium. It is probably the first time in Historical Society history that a political talk has drawn a full house on a Saturday afternoon at the beginning of final exams.

Reynolds, the former director of the Criminal Justice Center at the National Center for Policy Analysis, and the ex-top economist for George W. Bush's Labor Department, charged the Bush administration with gross malfeasance, and proposed the prosecution of top administration officials.

Normally, if a prestigious UW alumnus and ex-Bush administration official were to come to the Wisconsin Historical Society to spill the beans about a Bush administration scandal, it would make the news. And, of course, not a word in the national media.

Why the blackout? Because Reynolds violated the ultimate U.S. media taboo. He charges the Bush administration with orchestrating the 9/11 attacks as a pretext for launching a preplanned "long war" in the Middle East, rolling back our civil liberties, and massively increasing military spending.

When a former Bush administration insider makes such charges, how can the media ignore them? Is Reynolds a lone crank? Hardly. A long list of prominent Americans have spoken out for 9/11 truth: Rev. William Sloane Coffin, Sen. Barbara Boxer, former head of the Star Wars program Col. Are the media ignoring all these people, and dozens more like them, because there is no evidence to support their charges? Hardly. Overwhelming evidence, from the obvious air defense stand-down, to the nonprotection of the president in Florida, to the blatant controlled demolition of World Trade Center building 7, proves that 9/11 was an inside job. As noted philosopher-theologian and 9/11 revisionist historian David Griffin writes: "It is already possible to know, beyond a reasonable doubt, one very important thing: the destruction of the World Trade Center was an inside job, orchestrated by terrorists within our own government."

A growing list of scientists has lined up behind BYU physicist Steven Jones and MIT engineer Jeff King in support of Griffin's position, as evidenced by the growth of Scholars for 9/11 Truth (st911.org) and Scientific Professionals Investigating 9/11 (physics911.net).

As a Watergate-era graduate of the University of Wisconsin School of Journalism, I was taught that exposing government lies and corruption is the supreme duty of the Fourth Estate. 
