Re: Appeal of denial of a Web link to ShorewoodVillage.com

To each and every one addressed above:

Please provide answers to the following questions. Forgive me for not submitting the material sooner but although I provided a contact number for Mr. Harris, material was sent to an incorrect address and I did not get the schedule and rules until yesterday.

- 1. Evidence that all local, useful or news sites you link to have won awards;
- Evidence demonstrating the date you determined whether the sites linked to won awards;
- Evidence you looked at every other village web site published in Shorewood upon which you base your assertion that shorewoodvillage.com is no different than the others;
- 4. Evidence every other village web site has files documenting crimes committed by children of library employees;
- Evidence you have information about how many visitors shorewoodvillage.com has each day, and the information showing the number of visitors;
- 6. Evidence of the number of hits the other sites you link to provide;
- 7. Evidence that other Web sites published in the Village of Shorewood show Library Board President Jeff Hanewall received many campaign contributions equal to Ellen Eckman in the 2004 trustee campaign despite their assertions that their campaigns were independent;
- 8. Evidence the Library Board established a 45-day appeal period for residents who contest denial of a link from the Library Web site to their news or information site:
- Evidence that the Library had a policy for appeals of denials of links from the Library's Web site;

- 10. All records or evidence showing the process by which the Library decided to link St. Robert's School, Shorewood Men's Club, Journal Sentinel, the Herald, Hallmark card, and all other useful local and news links;
- 11. Correspondence from any other resident asking for a link;
- 12. All evidence or records showing all other sites that have been denied a link;
- Documents, records or evidence from all previous appeals of denials of a web link in which the acquisition policy was used;
- 14. Any and all documents or evidence that the denial of a Web link to ShorewoodVillage.com was not based on arbitrary whim, bias or retaliation for the content and viewpoint of ShorewoodVillage.com;
- 15. Any and all documents or evidence that the denial of a Web link to ShorewoodVillage.com was based on arbitrary whim, bias or retaliation for the content and viewpoint of ShorewoodVillage.com;
- 16. Evidence showing the Shorewood ordinances were not important before the Village Web site posted them, but they are important now;
- 17. All records, documents notes, records minutes, etc., detailing the closed meeting at which the Library Board met to discuss the development of a "fair appeal process," including the names of all persons present;
- 18. All notes, documents or records of any kind in which the intent or desire to use the appeal to legitimize or facilitate the denial of a web link to ShorewoodVillage.com;
- 19. Dates, times and places members of the Library Board discussed with Library staff the facts, allegations or testimony to be presented at the June 13 appeal of the denial of a link to ShorewoodVillage.com;
- 20. All records or documents, regardless of whether they are subject to the state public records act, in which there is a discussion or mention or suggestion of a legal theory or scheme between or among library staff, library board of directors, village officials, elected or appointed, residents or former village officials, including Rod Dow, Vida Langenkamp, Harvey Kurtz, Ray Pollen, Ellen Eckman or any attorney who does not represent the library board;
- 21. Names, address, telephone numbers, e-mail addresses, their relationship to the library employee or director and last known contact of everyone with whom you have expressed your views as to the merit of ShorewoodVillage.com's request for a Web link, your inclination, your criticism of the content, your feelings toward the Web site owner, Geoffrey Davidian, based on the content and viewpoint of ShorewoodVillage.com;
- 22. All records demonstrating that the Library Board approved the policy of using the book acquisition appeal process to apply to appeals of denials of links to Web sites.
- 23. Evidence that price comparisons at local grocers is not important, constitutes opinion and is available at every other village Web site;
- 24. Evidence that disciplined professionals in Zip Code 53211 is not important, constitutes opinion and is available on every other Shorewood Web site;

- 25. Evidence that contributors to local campaigns in searchable xls spreadsheet format is opinion, unimportant and available on every other Village Web site;
- 26. Records, laws, ordinances or policy demonstrating that following a link denial:
 - a. an appeal must be held within 45 days;
 - b. an appeal must not be held within 45 days;
 - c. an appeal must be held within 45 days but not for ShorewoodVillage.com;
- 27. Records, notes, evidence of any kind setting forth or defining the policy by which the Library Board enforces ethical violations by employees or board members;
- 28. Designate any and all content of ShorewoodVillage.com that reports on criminal behavior by library employees or their families, or campaign lies by Library Board members who ran for office that could be the basis for retaliation and denial of 1st amendment rights recognized for others.
- 29. All documents, records, ordinances, policies or other evidence that the Library Board endorses membership on an impartial appeal board by persons who dislike the content or the viewpoint of Web sites seeking a link to the Library Web site;
 - a. Evidence that such participation in an appeal is not an ethical or procedural violation;
 - b. Evidence that such participation is consistent with pursuit of justice.
