Geoffrey Davidian, reports that sometime between 7:00AM on Thu, 03/30/06, and 7:00PM, on Tue, 04/04/06 unknown actor(s) took down a homemade cardboard sign that was in his front yard and placed it on the ground. The cardboard sign had "Bush Supports Hanewall" written on it. The sign was attached to (2) wooden stakes with tape. It was replaced with a "Jeff Hanewall" campaign sign. This occurred at 4101 N. Prospect Ave., Village of Shorewood, State of Wisconsin, 53211 and was done without his consent or permission.

I took possession of both signs and the tape. I placed them in the back of my marked squad. I conveyed them to the Shorewood Police Department for processing. At the Shorewood Police Department I processed both signs for any possible fingerprint (s). I was unable to locate any usable fingerprints. I also attempted to locate any fingerprint(s) on the tape and none were observed.
